I, _____, parent of the above named child(ren) agree that by submitting my application for the 2026 Kidz Rock Summer Camp I understand the following:

- Kidz Rock Summer Camp is approximately ten weeks long. The official start and end of camp will be determined by the Monongalia County school calendar. If less than 10 weeks are available for the summer, I am only financially responsible for the number of weeks offered by KRSC. KRSC will not operate on Friday June 19th or Friday July 3rd.
- Kidz Rock Summer Camp will be offering a six week option. If chosen, weeks attending must be scheduled and turned in with your child's packet.
- KRSC 2026 will operate from 8:00am-5:30pm Monday-Friday. Before care will be available from 7:00am-8:00am for an additional charge of \$5 per ½ hour. After care will be available from 5:30pm-6:00pm for an additional \$5 charge per day. Before and after care MUST be scheduled in advance. A drop-in fee will also be charged for children attending before/after care without advanced scheduling.
- This application is for registration only and does not guarantee placement in KRSC.
- Official enrollment will be offered by the Director/ Assistant Director of SCELCL. I understand that there is a priority enrollment process and that my child(ren)'s enrollment is dependent upon availability.
- A \$50.00 registration fee per child is due with this application. Applications submitted without payment will not be processed. Registration/application fees are non-refundable for any reason.
- Once my child(ren) are offered enrollment in the camp, the activity fee (\$180.00/child) and completed enrollment packet are due to SCELCL on or before March 27, 2026.
- The tuition rate of \$210/week includes breakfast and snack daily. Lunch will be provided at a rate of \$232/week. Additionally, we have a six week option with a tuition rate of \$247/week that includes breakfast and snack daily. Lunch is provided for that option at a rate of \$270/week.
